

5. Superintendent Report - Dr. Rui Dionisio, Superintendent of Schools

Good evening everyone and welcome. We have certainly had our fair share of snow over the past week. I would like to thank our Verona Township Public Works and Mr. Higgins and the Verona Public Schools District Facilities Department for their efforts last week with snow removal. It was an incredible amount of snow totaling approximately 30 inches with little place to move it in a short amount of time. Thank you all for your efforts. On behalf of our school district, I had the opportunity to co-write a letter with our Essex County Superintendents to Governor Murphy petitioning him to prioritize COVID vaccine distribution for teachers and support staff who work closely with our students. We remain hopeful that we will have access to the vaccine as soon as possible. Additionally, our District has been collaborating with different medical providers and government officials in an effort to secure access to the administration of the COVID vaccine for our entire faculty and staff. Although we do not yet have confirmation on vaccine administration for our staff, we remain hopeful that it will become a possibility in the near future. Lastly, our elementary principals will provide an update on the progress and ideas from the elementary school reopening committee at the next Board of Education meeting on February 23rd.
