March - April 2023 Board of Education Finance Committee meets


March 14, 2023 Board of Education Public Meeting adopts the preliminary 2023-2024 school budget





- Continue to support Singapore Math Program, Dimensions, in grades K through 5 and implement Lesson Study with grade level teachers, building principals, math trainer (Mr. Jackson), STEM Supervisor, and Director of CIA
- Support new social studies series K-4, History Alive, in year 2 of implementation
- Support inquiry-based science K-4 STC Curriculum
- Year 2 of LETRS training with 30 staff members and in-house trainer,
 Mrs. Duffy
- Administer MAP Growth Assessments in math and reading to students in grades 1-4.

- Continue to support inquiry-based science STC 5-8 curriculum, including updating grade 5 with four new STC kits.

- Continue to support new math series, Amplify in Algebra I & II, implement Amplify Geometry, and continue to support professional learning with math trainer, STEM Supervisor, and Director of CIA using a Lesson Study Approach

BUDGET FACTS

- The general fund tax levy increase is 2.74% compared to prior year
- Tax increase is approximately \$215.70 per household
- The 2023 average assessed home is \$433,000
- The average school tax paid by residents last year was \$7,301
- Tax rates per \$100 of assessed valuation is \$\frac{1.73}{2}\$ for schools
